## 4. FIRST AID MEASURES

### Inhalation:

## **Ingestion:**

## **5. FIRE FIGHTING MEASURES**

## 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

### Long Term Effects:

No information available for the product. Repeated or prolonged breathing of silica dust may result in chronic lung diseases such as silicosis and potentially lung cancer. However, due to the particle size of the silica (sand) this is not expected to be relevant providing this product is used as recommended and good occupational work practices are observed.

**Toxicological Data:** No LD50 data available for the product.
