5. FIRE FIGHTING MEASURES

Hazards from combustion products:

Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. On burning will emit toxic fumes.

Suitable Extinguishing Media:

6. ACCIDENTAL RELEASE MEASURES

Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers.

Store in a cool, dry, well ventilated place and out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.

Precautions for safe handling:

Keep out of reach of children. Avoid skin and eye contact.
