10. STABILITY AND REACTIVITY

Chemical stability: Stable under normal conditions of use.

Conditions to avoid: Avoid contact with foodstuffs.

11. TOXICOLOGICAL INFORMATION

Ingestion: Swallowing may result in irritation of the gastrointestinal tract.

Skin contact: Contact with skin may result in irritation. May cause skin sensitisation in sensitive individuals. Repeated or prolonged skin contact may lead to allergic contact dermatitis.

Inhalation: Inhalation of dust and/or liquid mists (bioaerosols) may inflame or sensitise the nose, throat and lungs, and aggravate pre-existing conditions such as asthma and bronchitis.

Long Term Effects:

Repeated inhalation of dust and/or liquid mists (bioaerosols) may result in respiratory irritation, inflammation or sensitisation resulting in illnesses ranging from hayfever and asthma to pneumonia (eg. legionnaire's disease) and pneumonia like illnesses.
