## 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

### Skin Contact:

If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

**Eye Contact:**

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

**Ingestion:**

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Never give anything by the mouth to an unconscious patient. Seek medical advice.

**Indication of immediate medical attention and special treatment needed:**

## 5. FIRE FIGHTING MEASURES

**Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Extinguishing media appropriate to surrounding fire conditions.

**Specific hazards arising from the chemical:**

Non-combustible material.

**Special protective equipment and precautions for fire-fighters:**

Decomposes on heating emitting toxic fumes, including those of sodium orthophosphate, oxides of phosphorus, and sodium oxide. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency procedures/Environmental precautions:**

If contamination of sewers or waterways has occurred advise local emergency services.

**Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

Slippery when wet. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:**

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation.

**Conditions for safe storage, including any incompatibilities:**

Store in a cool, dry, well ventilated place. Protect from moisture. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

As published by Safe Work Australia Workplace Exposure Standards for Airborne Contaminants.

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## Appropriate engineering controls:

Ensure ventilation is adequate to maintain air concentrations below Workplace Exposure Standards. Keep containers closed when not in use.

If in the handling and application of this material, safe exposure levels could be exceeded, the use of engineering controls such as local exhaust ventilation must be considered and the results documented. If achieving safe exposure levels does not require engineering controls, then a detailed and documented risk assessment using the relevant Personal Protective Equipment (PPE) (refer to PPE section below) as a basis must be carried out to determine the minimum PPE requirements.

Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.

## 10. STABILITY AND REACTIVITY

<b>Reactivity:</b>	Phosphates are susceptible to formation of highly toxic and flammable phosphine gas in the presence of strong reducing agents such as hydrides. Hygroscopic: absorbs moisture or water from surrounding air.
<b>Chemical stability:</b>	Stable under normal conditions of use.
<b>Possibility of hazardous reactions:</b>	Hazardous polymerisation will not occur.
<b>Conditions to avoid:</b>	Avoid dust generation. Avoid exposure to moisture.
<b>Incompatible materials:</b>	Incompatible with oxidising agents and reducing agents .
<b>Hazardous decomposition products:</b>	Sodium orthophosphate. Oxides of phosphorus. Sodium oxide.

## 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

<b>Ingestion:</b>	No adverse effects expected, however, large amounts may cause nausea and vomiting. Swallowing large amounts may result in headaches, dizziness and a reduction in blood pressure (hypotension).
<b>Eye contact:</b>	May be an eye irritant. Exposure to the dust may cause discomfort due to particulate nature. May cause physical irritation to the eyes.
<b>Skin contact:</b>	Contact with skin may result in irritation.
<b>Inhalation:</b>	Breathing in dust may result in respiratory irritation.
<b>Acute toxicity:</b>	Oral LD50 (rat): >2400 mg/kg.

**Chronic effects:** No evidence of carcinogenicity. No evidence of mutagenic properties. No evidence of reproductive effects. No evidence of teratogenic properties. Repeated ingestion of some phosphates (120-240 gm/kg/day) has been shown to cause increased calcium excretion and soft tissue calcification in man.
