4. FIRST AID MEASURES

Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

Skin Contact:

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye Contact:

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport promptly to hospital or medical centre.

Ingestion:

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

7. HANDLING AND STORAGE

Precautions for safe handling:

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation.

Store under cover in a dry place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

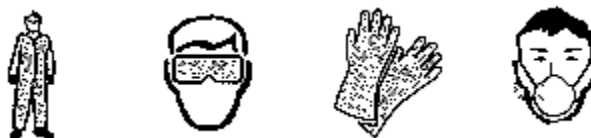

Ingestion:	Swallowing can result in nausea, vomiting, diarrhoea, and abdominal pain. May cause burns to mouth and throat.

Chronic effects: Repeated or prolonged breathing of silica dust may lead to pulmonary disorders including silicosis and cancer. Crystalline silica is a Category 1 Human Carcinogen.

Repeated or prolonged skin contact may cause dryness and dermatitis.

Carcinogenicity: May cause cancer.
Specific Target Organ Toxicity (STOT) - single exposure: May cause respiratory irritation.
Aspiration hazard: Not classified.

This material contains crystalline silica. Crystalline silica has been shown to cause silicosis and lung cancer. Crystalline silica only causes these conditions when inhaled. Long-term inhalation overexposure to crystalline silica can cause silicosis, a form of lung fibrosis (scarring). It may be progressive and can lead to disability and death. For crystalline silica (inhaled in the form of respirable quartz or cristobalite from occupational sources): This material has been classified by the International Agency for Research on Cancer (IARC) as a Group 1 agent. Group 1 - the agent is carcinogenic to humans.

This material may contain trace amounts of chromium VI. For Chromium (VI): Chromium (VI) compounds cause cancer of the lung. Positive associations have been observed between exposure to chromium (VI) compounds and cancer of the nose and nasal sinuses. This material has been classified by the International Agency for Research on Cancer (IARC) as a Group 1 agent. Group 1 - The agent is carcinogenic to humans.
